Description:	At the request of the National Agricultural Products Quality Management Service, the CB SC CAAE (ES-ECO-001-AN) confirmed that both the attached NAQS import certificate and the certificate of the operator EVO ORGANIC FOODS were false. This operator was certified by another CB (SOHISCERT ES-ECO-002-AN).
