Title:	Non_compliant fertilisers labelled "for use in organic production" imported from China with high level of ammonium nitrogen			
Description:	Many fertilisers imported from China with high level of ammonium nitrogen were controlled on the French market and declared non-compliant with regulation 2021/1165, considered as ammonium stillage : Azopril N13, Nova N12-0-3, Orgamax 15-5-0-2, Solferti 11-0-5, Solferti 7-0-7-S. These products are suspected to be on the European market under different names and distributed by European operators to organic sector (see the table enclosed)			
Seriousness assessment:	the high level of ammoniacal nitrogen in these products >50% related to nitrogen total see the labels enclosed
