A suspicion of fraud was raised concerning the organic certificate provided from the supplier/ exporter Ericam International.

As "Bio" marketed quinoa from Ericam International is currently being shipped from Cameroon to Rotterdam ( Netherlands). The date of arrival is unknown.

Hedo Dokkum B.V. is planned as the first consignee and packer of the goods. However, the organic certificate from Hedo Dokkum B.V. that was provided does not inckude first consignment and the operation is not to be found in traces nt.

Except of the purchase contract and the fake certificate, no further documents were provided. The goods supposedly left Cameroon mid-august. The supplier/ exporter has not sent any import documents and has been unresponsive.
